<p>The Graduate School of Law awards the Master’s degree (Law) to students who, within the prescribed period, complete the designated subjects, earn the required credits, and submit a master’s thesis under the guidance of academic advisors. The qualification for completion is evaluated based on the acquisition of the following knowledge and abilities:</p> <p>1. Knowledge and Skills To have acquired the academic knowledge necessary to function as a researcher or a highly specialized professional in law or political science—namely, knowledge of current laws and modern politics grounded in historical and ideological understanding. Students must also acquire the skill to appropriately and promptly locate information from judicial precedents, scholarly theories, and recent political developments, and the ability to analyze these comprehensively from legal or political perspectives.</p> <p>2. Abilities of Thinking, Judgement, and Expression To be able to address various contemporary social problems from broad perspectives, including international trends; to explain such issues scientifically based on an accurate understanding of legal and political systems; and to develop convincing arguments informed by norms and historical experience. Through specialized subjects and the study of foreign literature, students ultimately acquire the ability to “Think and Act” so as to contribute to democratic decision making. Students must also acquire the ability to identify unresolved issues and solve problems through fair and flexible thinking based on concrete analysis of legal disputes or political situations.</p> <p>3. Proactive Attitudes To have developed the capacity to select a significant research theme grounded in judicial precedents, academic theories, contemporary political conditions, and one’s future career path; to identify unresolved issues; to formulate an appropriate research plan; and to conduct research in accordance with that plan. Students must also acquire the attitude necessary to engage in academic dialogue and exchange through research presentations</p>	<p>The Graduate School offers the Legal and Political Studies Course for fostering researchers, the Highly Specialized Professional Course for cultivating advanced professionals, and the Global Cooperation Course to support the development and academic contributions of international students. The curriculum is organized as follows:</p> <p>1. Educational Contents:</p> <p>(1) Knowledge and Skills The Legal and Political Studies Course aims to cultivate research ability and foundational academic knowledge necessary for independent scholarly activity. Students, in principle, take seminars each year under the same academic advisor. Through specialized subjects and study of foreign literature, students develop the ability to read and understand foreign academic materials. The Highly Specialized Professional Course and the Global Cooperation Course aim to foster advanced professionals with specialized expertise. Students receive practical education consisting of basic, lecture, and seminar subjects. Basic subjects provide foundational knowledge and skills; lecture subjects address advanced legal and political issues with historical and ideological context; seminar subjects focus on preparing the master’s thesis or research report.</p> <p>(2) Abilities of Thinking, Judgement, and Expression Students develop these abilities mainly through seminar subjects. In the Legal and Political Studies Course and the Global Cooperation Course, thesis seminars are regularly supervised by the academic advisor. In the Highly Specialized Professional Course, students receive dedicated guidance in the first year and further advice on specialized research themes in the second year. Problem-solving skills are cultivated through the General Seminar (Theme).</p> <p>(3) Proactive Attitudes Students develop proactive attitudes by formulating research plans, reporting progress to academic advisors, and submitting the Annual Research Results Report to the Dean. Opportunities for research presentations on and off campus and submissions to academic journals are provided. Ethics training and practice-oriented classes further strengthen awareness of the relationship between theory and practice.</p> <p>2. Evaluation of Learning Achievements:</p> <p>(1) Knowledge and Skills Assessment is conducted mainly through basic subjects and lecture subjects. Evaluation focuses on the understanding of advanced knowledge in law and political science, logical and scientific explanation, construction of persuasive arguments, and the ability to reach reasonable conclusions through discussion.</p>	<p>The Graduate School of Law accepts applicants who can contribute to democratic decision making through logical and well-reasoned arguments based on accurate expertise in law and political science. Applicants are required:</p> <p>1. Expertise and Communication To possess basic expertise in the historical development of legal and political institutions; sufficient knowledge to understand arguments in foreign countries; and the ability to express their own views accurately and understand those of others.</p> <p>2. Openness to Diversity and Scientific Explanation To demonstrate willingness to recognize the significance of diverse perspectives rooted in different cultures and values, and to explain issues scientifically based on accurate legal and political knowledge, reaching mutual understanding through well-founded arguments.</p> <p>3. Problem-solving Ability and Democratic Engagement To have the ability to solve problems through fair and flexible thinking, to engage actively with social phenomena, to form opinions through reference to legal and political expertise, to act toward solutions by reconciling competing interests in a democratic manner, and to present such solutions in the form of a master’s thesis or research report.</p>

<p>The Graduate School of Law awards the Doctoral Degree (Law) to students who complete the designated subjects, earn the prescribed credits, and submit a doctoral thesis under the guidance of academic advisors within the prescribed period. The qualification for receiving the degree is judged based on the acquisition of the following knowledge and abilities:</p> <p>1. Knowledge and Skills</p> <p>To have acquired the knowledge required to act as independent researchers of law or political science—namely, knowledge of current laws or modern politics grounded in historical and ideological understanding. Students must also acquire the skills to appropriately locate information from judicial precedents, scholarly theories, and recent political conditions, and gain the ability to analyze these comprehensively from legal or political perspectives and respond flexibly.</p> <p>2. Abilities of Thinking, Judgement, and Expression</p> <p>To have acquired wide-ranging perspectives by collecting, translating, and understanding foreign literature, as well as the ability to address contemporary social issues through an understanding of foreign legal or political systems. Students must be able to explain such issues scientifically based on an accurate understanding of legal or political systems, develop convincing</p>	<p>The Graduate School aims for students to acquire the knowledge, skills, qualities, and attitudes required by the Diploma Policy and to foster researchers who possess advanced knowledge of law and political science and can utilize it effectively in various fields of society. The Graduate School offers the Legal and Political Studies Course, and the curriculum is structured on the following basis:</p> <p>1. Educational Contents:</p> <p>(1) Knowledge and Skills</p> <p>The Ph.D. Degree Program aims to cultivate highly advanced research ability and substantial academic knowledge necessary for independent scholarly activity. Students, in principle, take small-group seminars each year under the same academic advisor. Through specialized subjects and the study of foreign literature, students also acquire the ability to read and understand foreign academic materials</p> <p>(2) Abilities of Thinking, Judgement, and Expression</p> <p>In the Ph.D. Degree Program, seminars for the doctoral thesis are regularly conducted under the guidance of the academic advisor.</p> <p>(3) Proactive Attitudes</p> <p>The Graduate School provides opportunities for students to present their research widely through academic meetings and conferences, or through submissions to academic journals such as <i>The Law Review of Kansai University</i> and <i>The Journal of Law</i>. Whether the research contributes to academic development.</li> <li>iii. Whether the student’s problem awareness and issue setting are clearly stated.</li> <li>iv. Whether the dissertation appropriately and sufficiently analyzes and cites prior research and materials.</li> </ul> <p>(2) Abilities of Thinking, Judgement, and Expression</p> <p>In lecture subjects, the Graduate School evaluates students’ ability to make logical and scientific explanations, construct well-founded arguments, and draw reasonable conclusions through reports and discussions.</p> <p>(3) Proactive Attitudes</p> <p>In seminars conducted by the academic advisor, the Graduate School evaluates students’ attitudes and abilities to study and solve issues using their own knowledge and thinking. <p>The Graduate School of Economics' educational aim is to develop human resources with an international perspective, specialized knowledge, and advanced research abilities. When awarding a degree, the Graduate School place emphasis on achieving that goal. When conferring degrees, to ensure its transparency a certain period of public notice is required, and oral examinations will be open to the public. Specifically, the Graduate School will award a master's degree in economics to those who have acquired the following knowledge and skills, abilities such as thinking, judgment, and expression, and an independent attitude.</p> <p>1. Knowledge and Skills</p> <p>Students will have advanced knowledge and skills, requirements to be active as economics researchers or highly specialized professionals, and will be able to utilize them comprehensively.</p> <p>2. Abilities of Thinking, Judgment, and Expression</p> <p>Students will be able to contribute to society through an international perspective, leveraging their high level of expertise in economics, and demonstrating a high level of “Think and Act”.</p> <p>3. Proactive Attitudes</p> <p>(1) Be able to take responsibility for one's own learning and independently tackle unresolved issues related to economics.</p> <p>(2) Students will be able to use their knowledge of economics to proactively tackle various domestic and international issues that are actually occurring.</p>	<p>At the Graduate School of Economics, as stated in the diploma policy, educational curriculum is organized so that students can acquire knowledge and skill abilities, such as thinking, judgment, and expression, as well as an independent attitude, based on the following points:</p> <p>1. Educational Contents:</p> <p>(1) In response to economic and social changes, and to meet various motivations and student needs upon admission, the Graduate School established two programs: Graduate programs for Professional Development and Academic Development. <p>In accordance with the educational philosophy of the Law School, the Law School (Professional Degree Program) awards a Juris Doctor to those who possess advanced specialized knowledge, and have acquired abilities suitable for becoming legal professionals with a strong sense of ethical responsibility. Specifically, the requirements for receiving this degree are that students must have been enrolled for at least the prescribed period. In addition, students would have completed their education following the curriculum, which has been established in light of the Law School's educational philosophy. Moreover, students should have completed a number of credits specified by the Law School, including specified credits in the following courses: Legal Basic Course, Legal Practical Basic Course, Applied/Advanced Course and Legal Basic/Adjacent Course. In addition, in order to better achieve our educational philosophy, the requirements for advancement stipulate that each academic year, in addition to acquiring the designated number of required credits, students must also meet the GPA standards for compulsory subjects.</p>	<p>The Law School (Professional Degree Program) offers the following distinctive curriculum to achieve its educational philosophy of developing legal professionals with three important qualities: (1) a balance of theory and practice, (2) an excellent sense of human rights, and (3) the creativity to address new issues.</p> <p>First, the Law School provides a legal basic course which is not limited to abstract theoretical education, but constantly gives consideration to systematic learning based on examples, and are intended to offer a full range of practical subjects for training legal professionals while also being aware of building bridges to practical education. Second, the Law School provides a legal practical basic course such as legal ethics and legal clinics with the aim of cultivating professional ethical standards, human understanding and sound judgement. Third, the Law School provides advanced subjects of law with "Lecture 1" offered as an introductory course for many subjects, enabling students to study a wide variety of advanced legal fields. "Lecture 2" (and a possible further "Lecture 3" depending on the subject) and practical exercises are offered to enable students to obtain deeper specialized knowledge in applicable legal fields. Fourth, in order to acquire knowledge about international law and foster international perspectives, the Law School provides lectures and practical exercise subjects by instructors who are also lawyers specializing in Chinese business law, and focus on topics and practical matters related to international contracts. In addition, the Law School also provides lectures on English for business law, and practical exercise subjects focused on international legal relations. Overseas externships are also conducted with cooperation from the Japan International Cooperation Agency (JICA). Fifth, in order to develop broad insights into new legal issues, the Law School also provides interdisciplinary subjects such as special lectures of contemporary legal issues (individual themes) and subjects related to law and society.</p>	<p>The Graduate School of Law, whose predecessor was Kansai Law School, advocates the professional education and development of law students. In order to achieve the educational philosophy of "GAKU-NO-JITSUGE" (or Harmony between Academia and Society, and between Theory and Practice), through the social practice of law, students: (1) achieve a balance between theory and practical ability, (2) develop an excellent sense of human rights supported by a broad range of study and professional knowledge, and (3) attain the creativity to address new issues arising in our increasingly complicated and diversified modern society.</p> <p>Based on this philosophy, our admissions selection process reviews whether applicants have acquired sufficient education and professional knowledge through undergraduate education, and whether they have the basic abilities for development into legal professionals (the abilities to read and comprehend, to analyze, and to express themselves in writing). Prior to enrollment, students who wish to study graduate courses and have acquired legal knowledge will be screened. This screening will determine the students' fundamental knowledge and abilities related to basic legal subjects, in addition to the above requirements. Furthermore, in order to ensure openness and diversity, an entrance examination system has been established in which examinations are conducted with an emphasis on experience as a member of society.</p>
